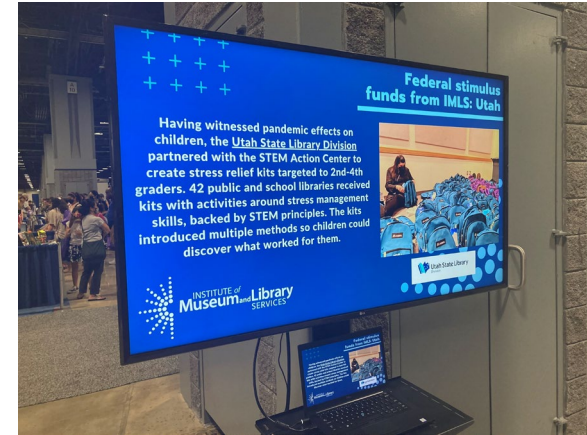

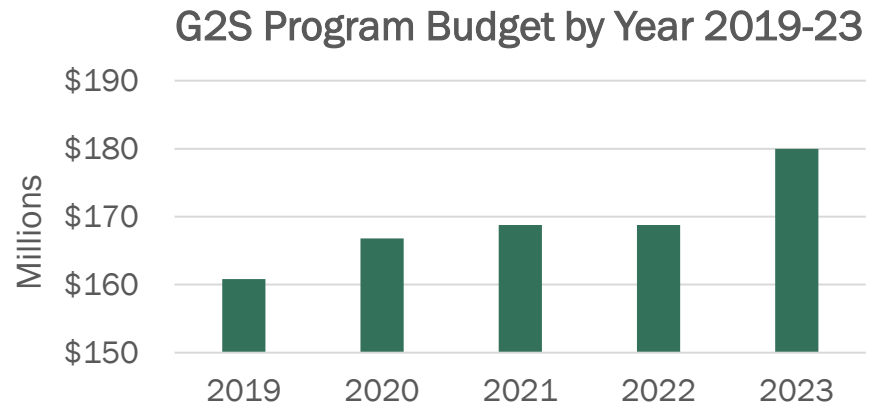




2023 Allotments

- Program budget increase to \$180M
- Base of \$1M for states/\$100K for territories now enacted

Note: the previous base increase, from 2003-2009, took 7 years; this one took 5



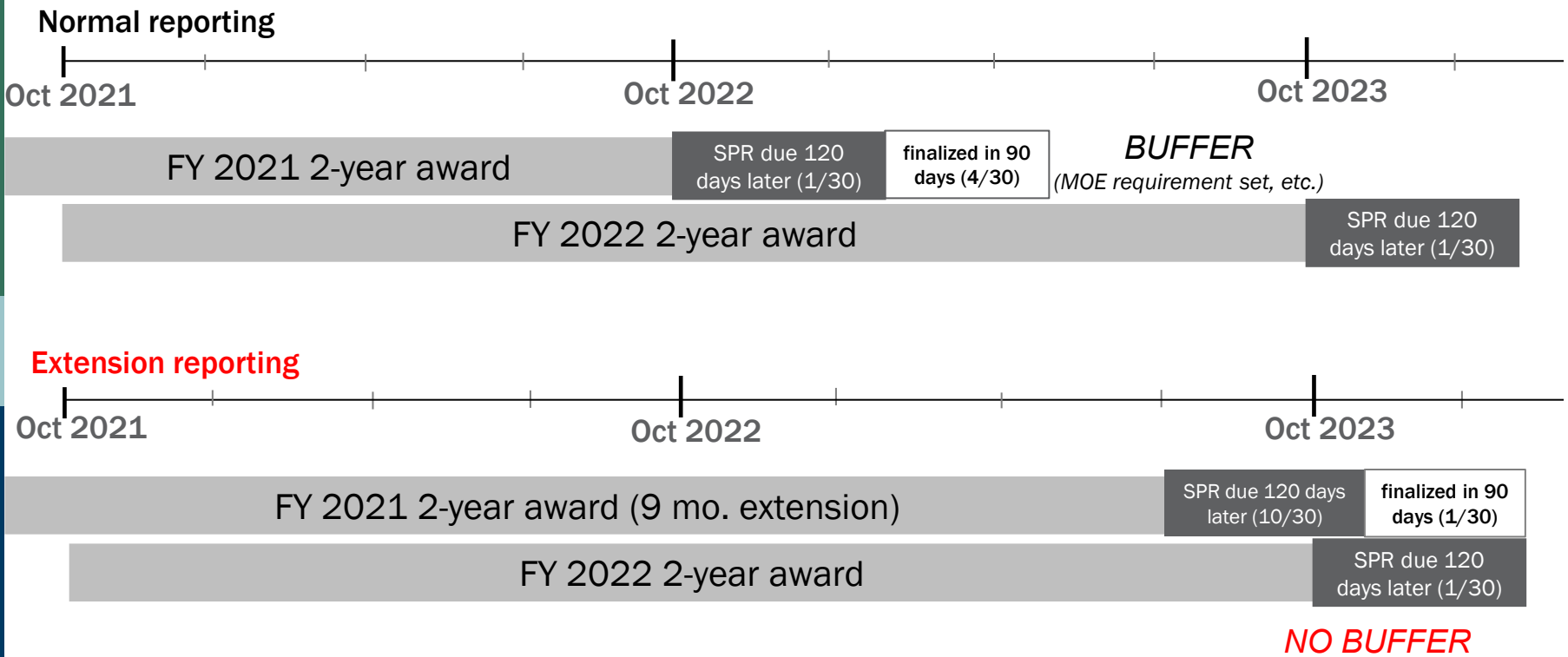


Extensions and G2S

- Many extensions given for ARPA because of extenuating circumstances
- Resetting to prior norm for FY22 and beyond: extensions are VERY RARE for Grants to States
- If you still have supply chain issues, etc., the ideal timeframe to hear about a need for an extension would be July or August, BEFORE the award ends

Unique Entity ID (UEI)

- Became the official identifier for doing business with the U.S. government after April 4, 2022.
- Info must be validated against other data sources to help prevent improper payments, deter procurement fraud, and maintain the integrity of government contracts and grants processes.
- After the first validation, organizations only have to renew their SAM.gov registrations annually.

- *Helpful Hint:* Renew your SAM.gov registration each year. Don't risk having to start over.

Login.gov (used for eGMS Reach)

- Allows use of one account and password for secure, private access to participating government agencies.
- Uses a variety of authentication methods to protect this U.S. government service and your data, and to ensure the service remains available to all users.

How to Get Paid Fast

- Submit your payment request through your eGMS Reach account using the Payments tab.

Helpful Hints

- **Submit no more than two payment requests per month per award.**
- Choose either advance or reimbursement payment, but not both for the same period of time. Use mutually exclusive dates.
- Know your award's end date. Don't request funds for a date that occurs after your award's period of performance has ended.



Limited English Proficiency (LEP)

- IMLS currently requires SLAAs to have LEP policy
- New federal guidance coming out
- IMLS can consider setting up a webinar with the Department of Justice to learn more
